I affirm that I am a legal resident of the United States and that I was 18 years of age or older as of April 1, 2014.

For valuable consideration, receipt of which is hereby acknowledged, I hereby irrevocably grant to Sponsor, its respective subsidiaries, affiliates, and advertising and promotion agencies, their successors and assigns, and anyone authorized by any of them, forever hereafter, the right to copyright and renew and/or use, separately or together, my name, picture, likeness and/or biographical materials, in whole or in part, in any and all media, in connection with this Contest and similar promotions. In connection therewith, I hereby release and agree to hold harmless each of them and their agents and contractors from any and all claims of any kind which I, my heirs, executors and assigns may have on account of such use.
